TERMS AND CONDITIONS OF CONTRACT

Area of application

The present Agreement applies to the consulting services provided by the company ECOSPEED AG (hereinafter referred to as ES) for the ordering party (hereinafter referred to as the Customer) insofar as they do not contradict other agreements between ES and the Customer. Other agreements between ES and the Customer only take precedence over this Agreement if they have been agreed in writing, concluded with reference to this Agreement, and have been signed by both parties. The General Terms and Conditions of Business of the Customer shall not apply.

Object of the Agreement and services

The content and scope of the consulting service of ES are defined in the service description on this order form. The consulting packages are offered as supporting services for handling the software. Conclusion of this Agreement for support consulting packages shall not give rise to any entitlement on the part of the ordering party to a verifiable reduction in the initial skill adaptation overhead (not a contract for work and services). If ES carries out a plausibility check of the environmental balance for the Customer, ES shall assume no liability whatsoever for the balance quality of the Customer. The specified price refers to the balance plausibility check of a region. Communities receive a price on request. ECOSPEED and ECOSPEED products may only be mentioned in the context of queries related to the balance check.

Other product and service descriptions, in particular product and service descriptions on the internet site of ES and the ES documents stored there, are not part of this Agreement. This Customer cannot derive any rights in relation to ES from the above.

Prices

The prices specified on this order form and legally agreed by acceptance of the order by ES shall apply.

Start of the contract, term of contract, and notice of termination

The stipulations of this Agreement shall apply and be regarded as effectively agreed on acceptance of the order by ES. The Agreement shall be valid for the duration of 1 year, commencing with the day the order arrives at ES and shall end automatically once this year has elapsed. Thereafter, the Agreement can be extended in writing by another year at the request of the Customer.

Billing for the offered services shall take place on receipt of this order. In the event of premature contract termination, non-use, or partial non-use of the services, the Customer shall not be entitled to any rebate.

ES shall be entitled to terminate all consulting services without prior notice and without compensation and to give notice of termination of the Agreement if reasonable doubt arises as to whether the consulting services are being used by the Customer in a manner that complies with the law or the terms of the Agreement.

Place of jurisdiction and applicable law

It is agreed that disputes arising from this Agreement shall be dealt with in the courts at the registered office of ES (Zurich, Switzerland). The Agreement is subject to Swiss law.
